Inviting Quotation from eligible bidders for providing and fixing the aluminium partition works at NaCSA AOC Laboratory located at Kudhitapalem Village, Indukurupeta Mandalam, SPSR Nellore District, Andhra Pradesh - 524313.

### Introduction:

The **National Centre for Sustainable Aquaculture (hereinafter referred as "NaCSA)** is a society registered under the AP Societies Registration Act 35 of 2001 under the administrative control of The Marine Products Exports Development Authority (hereinafter referred as "MPEDA"), Ministry of Commerce and Industry, Government of India. NaCSA with its Head office at Boat Club Road, Ramanayyapeta, Kakinada, East Godavari District, Andhra Pradesh is entrusted with the forming of clusters of shrimp farmers as primary task of promotion of export of marine products from India.

### Job Description:

Providing and fixing the aluminium partition work of approximate **500 Sft** with door, half glass and powder coated (white) : **Glass** : 5 mm thickness, **Novapan Board**: 12 mm thickness **Aluminium Sections** : 2 ½ X 1 ½ (1.2 mm) sections of approved make conforming to IS: 733 and IS: 1285, fixing with dash fasteners of required dia and size, including necessary filling up the gaps at junctions, i.e. at top, bottom and sides with required EPDM rubber/neoprene gasket etc. Aluminium sections shall be smooth, rust free, straight, mitred and jointed mechanically wherever required including cleat angle, Aluminium snap beading for glazing / paneling, C.P. brass / stainless steel screws, all complete as per architectural drawings and the directions of In-charge. Providing and fixing the new Door (half partition Glass door) in the existing partition with necessary Door Closer, Door Lock, Door Handles and Door Stopper etc.

### General Instructions:

1. You are required to visit the sites to know about the requirement in person on any working day during office hours.
2. The material specified has to be strictly adhered to and the workmanship should be of superior quality.
3. You should make your own arrangements to transport the materials to the site.

4. Quality of work carried out shall jointly be taken by you/ your representative and NaCSA and payment shall be actual work one.
5. The work is to be completed with 25 days from issue of the work order.
6. Quantities show in this notice is approximate and payment shall be made as per actual quantities / measurements.
